



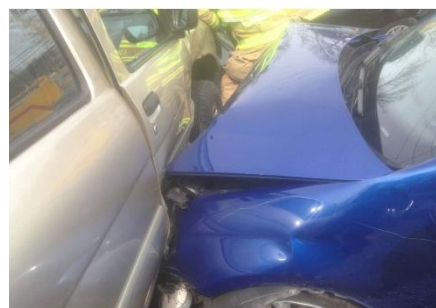

## FWY RECEIVES \$300,000 SETTLEMENT FOR CLIENT IN MOTOR VEHICLE ACCIDENT

FWY recently settled a plaintiff motor vehicle accident case for \$300,000. The client was a married father from Upton, MA. On or about March 17, 2014, the client was operating a motor vehicle on Rte. 140 in Milford, MA. The defendant exited from a parking lot and struck the client's vehicle on his passenger side. The impact was so severe the client's vehicle went up and over the curbside and knocked over a large landscaping boulder, before finally slamming up against two parked motor vehicles.



The client suffered severe bodily injuries, including leg fractures, which caused extensive rehabilitation. FWY thoroughly investigated the accident by obtaining the police report, photographs, and eye witness testimony from witnesses at the scene of the accident. Through these efforts, the defendant's bodily injury policy of \$50,000 was quickly allowed and paid.

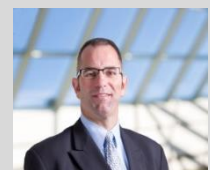
The case was interesting in the fact that the client had substantially large Underinsurance Motor, or "UM", coverage in the limits of \$300,000. In the state of Massachusetts, however, stacking policies is prohibited. Therefore, FWY could only obtain an additional \$250,000 from the UM coverage. After preserving the client's right to pursue the policy (by obtaining the appropriate acknowledgements from the insurance companies), FWY negotiated an additional settlement - \$250,000 - the full amount on the UM coverage.
